3.2 REGISTERED OFFICE:

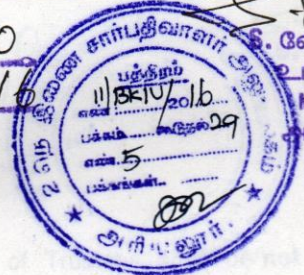

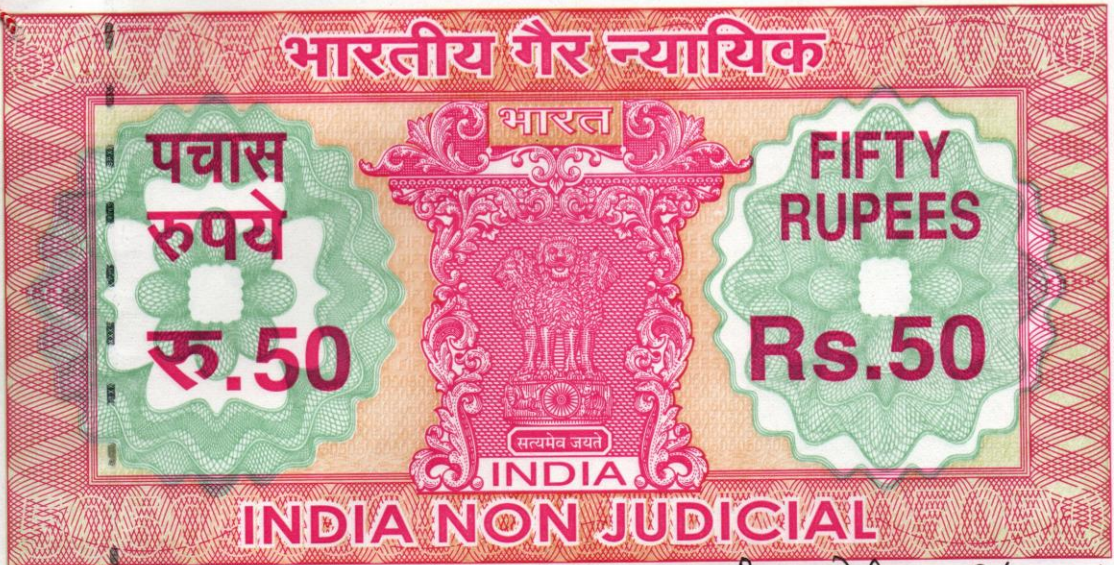

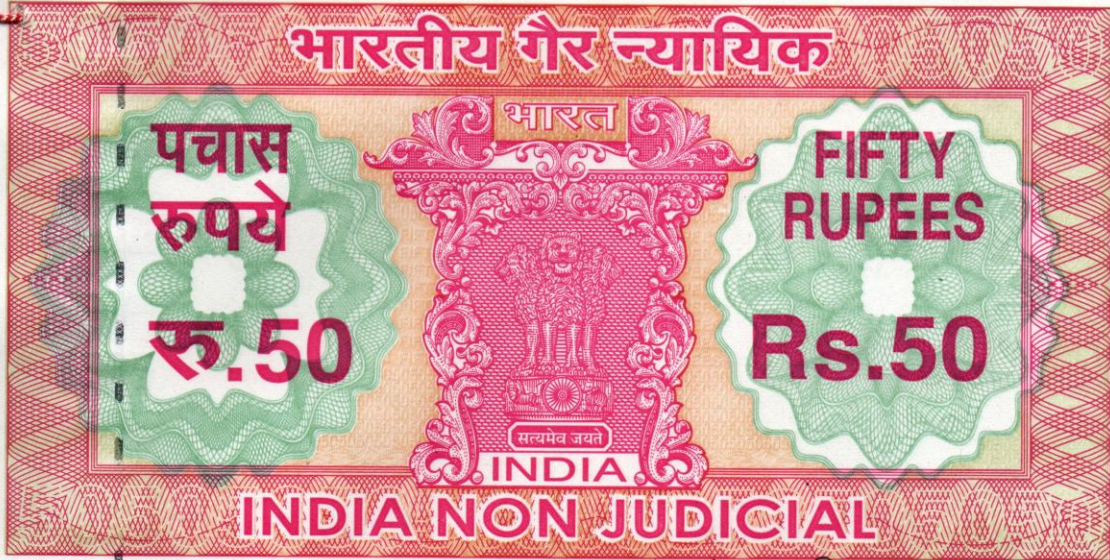
4.2. (a). The Board of Trustees shall be not less than two and not more than Ten.

(b). Except in otherwise a specific resolution passed or either in the case of First trustees and nominee trustees on behalf of First Trustees or a legal heir of First Trustees or any other new trustees, the duration of office bearer of the Board of Trustees shall be three years except the life time office bearer First trustees. The retiring trustees who hold office bearer of Board of Trustees shall be eligible for reappointment.

4.3. MANAGEMENT OF TRUST:

This Trust shall be administered by a Board of Trustees Whose Number shall not be less than Two and not more than Ten. The Trustees shall elect a President, a Secretary, a Treasurer from among themselves once in 3 years except during the period of life time First trustees who hold office bearer of the Board of Trustees and the retiring trustees of office bearers shall be eligible for reappointment. 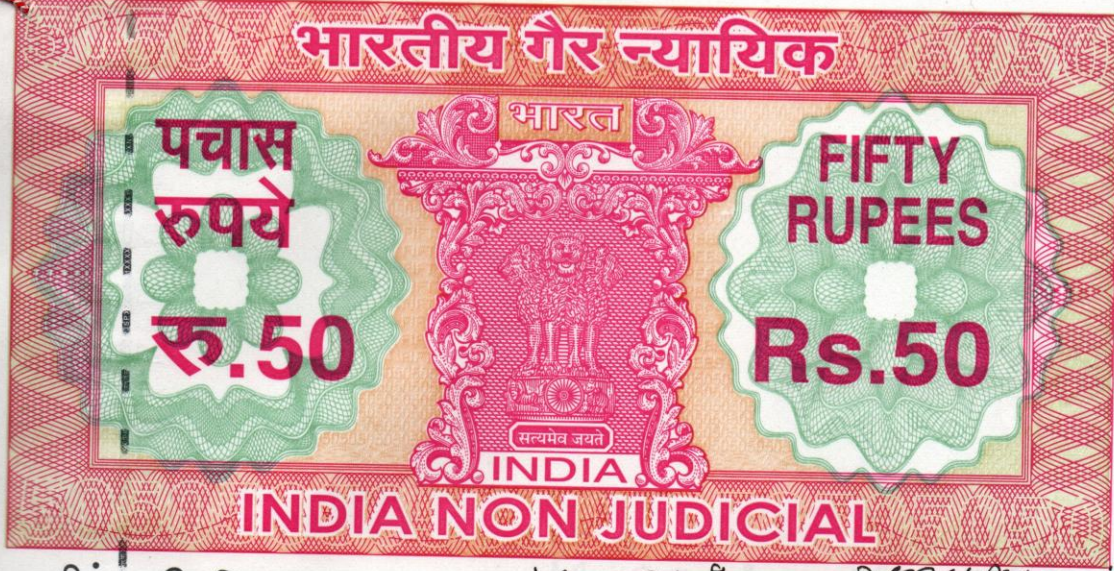

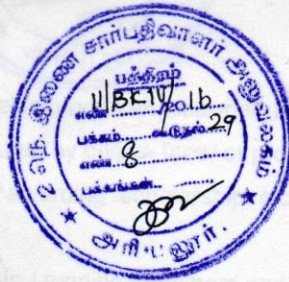

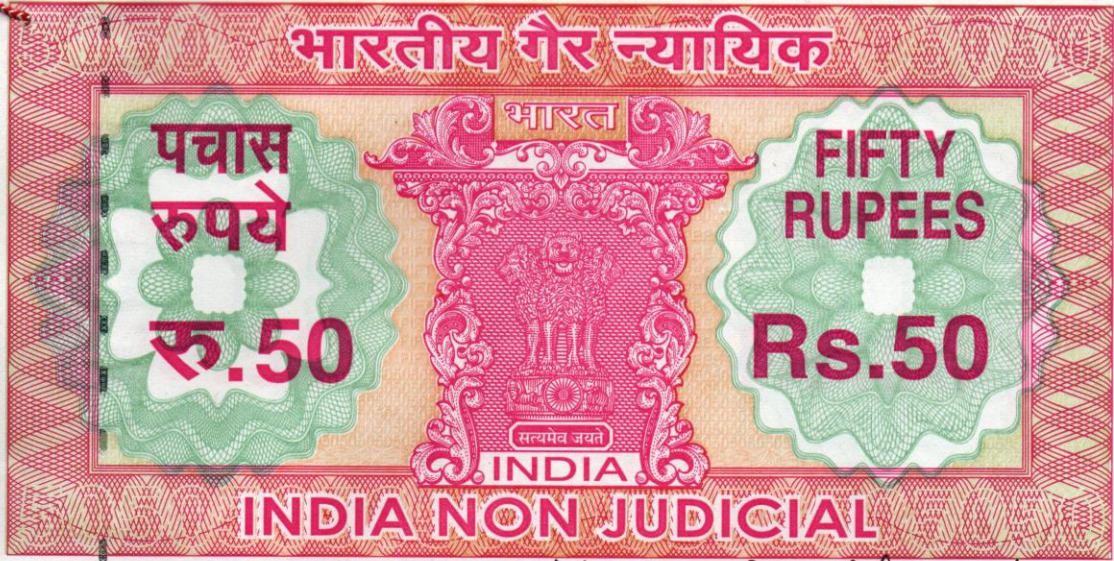


5.2. OBJECTS OF THE TRUST:

(x). To the relief of unemployment for the benefit of the public in such ways as may be thought fit, including assistance to find employment.

(y). To assist in the treatment and care of persons suffering from mental or physical illness of any description or in need of rehabilitation as a result of such illness, by the provision of facilities for work and recreation.

(z). To the relief of the sick-poor living places either generally or individually through the provision of grants, goods or services.

(aa). To provide or assist in the provision of facilities in the interests of social welfare for recreation or other leisure time occupation of individuals who have need of such facilities by reason of their youth, age infirmity or disability, financial hardship or social circumstances with the object of improving their conditions of life.

(ab). To the relief and assistance of people in any part of our Country of India who are the victims of war or natural disaster, trouble, or catastrophe in particular by the supply of medical aid to such persons.

(ac). To further or benefit the residents of any area and the neighborhood, without distinction of sex, sexual orientation, race or of political, religious or other opinions by associating together the said residents and the local authorities, voluntary and other organizations in a common effort to advance education and to provide facilities in the interests of social welfare for recreation and leisure time occupation with the objective of improving the conditions of life for the residents and establishing community centre for the aforesaid purpose.

5.3.BENEFIT OF THE TRUST:

The Benefits of the Trust are open to all irrespective of creed, caste, community, religion, race, sex etc. And the Trust will not carry on any activities with an intention of earning profit.

6. THE PROPERTIES OF THE TRUST

The properties of the Trust shall be.-

(a) the said sum of **Rs.5000/-** [Rupees Five Thousands only] above referred to the receipt of which is hereby acknowledged by the Trustees;

(b) **at presently the trust not owned any properties of movable or immovable**, but in future that may be acquired by the Trust either by purchase or lease or otherwise;

(c) all additions and acceptations to the Trust fund;

(d) all voluntary donations both towards corpus or otherwise gifts, legacies or grants in cash or in kind accepted by the trustees;

(e) all grants and contributions made to the Trust by the Government, Government bodies, Trust or Institutions, Trade Union or Societies etc; and

- (f) all sums and assets which by and means become the property of the Trust.

7. CESSATION OF TRUSTEESHIP:

A Trustee mentioned below shall cease to be the trustee of the Trust if:

- (a) he resigns;
- (b) he becomes insolvent;
- (c) he deceased
- (d) he unsound mind
- (e) He is removed by the majority of the members of the Trust, if it is found that the trustee(s) activities are detrimental to the activities or administration or funds of the Trust by means of fraud, immoral and illegal.



8. APPOINTMENT OF TRUSTEES:

- a) Any Vacancy in the Board of Trustees shall be filled up by the remaining members of the Trust selecting a suitable person among the legal heirs of the existing trustees in who is place become vacant by passing a resolution to give effect in this regard by the board of trustees from time to time.
- b) The Board of Trustees shall be decide to appoint the new trustees by selecting a suitable person either among the family members or any other suitable person outside the family members of the trustees, they deem fit to act as trustees shall be appointed by passing a resolution to give effect in this regard by the board of trustees from time to time.
- c) No vacancy in the Board of Trustees shall invalidate any act or decision of the other Trustees constituting the Board of Trustees.
- d) Alternate trustees- it shall be lawful for any of the Trustees who may be absent from India for more than 180 days or is disabled by sickness, to appoint any other person of his choice as alternate Trustee, to function as such Trustee during his absence or for such term as the absent trustee determines.

RAMESH** aged about 33 years old and residing at Door No.22/E, Kallakudi Street, Ariyalur, Ariyalur District-621704 Who shall hold office as SECRETARY-CUM-TREASURER of the Board of Trustees in her life time. . [ID and Address Proof: Adhar Card UIAI No.961009565980]

10. POWER OF THE TRUSTEES;

The Board of Trustees shall have the control and management of the Trust and exercise the following powers:

- a) To determine from time to time to commence and to take up the object and purposes for which the funds of the trust shall be used and allot and allocate to each of the objects such portion of the funds as they deem fit;
- b) To purchase and acquire or for lease any immovable property of any kind for this object of the Trust or as a source of income for the Trust;
- c) To sell, mortgage, for lease or dispose of any immovable property/properties belonging to the Trust;
- d) To incur all expenditure necessary as in their own opinion useful for carrying out the objects and administration of the trust;
- e) To open one or more bank accounts of the trust with any bank or banks as the Trustees may deem fit and deposit monies of the Trust in the Bank accounts.
- f) To borrow all type of loans for and on behalf of the Trust with or without security from banks, Governments, Trust, Companies, Universities or any other



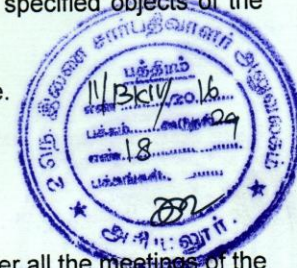

government Body/bodies both central and state or any other persons or organizations;

- g) To employ staff of all kinds necessary and useful for carrying out the objects of the trust.
- h) To incur such other items of expenditure as is necessary and incidental for carrying out the objects of the Trust;
- i) To institute, conduct, defend, compound, withdraw, compromise, adjust, refer to arbitration or to do such things as are incidental and necessary, concerning the affairs of the Trust and to sign and verify vakalats, pleadings, affidavits and other powers'
- j) To delegate all or any of the powers vested in the Trustees to anybody' to frame rules, bylaws and other codes for the conduct of the affairs of the Trust and its transactions and establishing any Committee;
- k) To accept contributions in cash, cheques or in kind either by way of addition to the trust funds generally or for any one or more of the specified objects of the Trust.
- l) To establish as many adhoc committees for any purpose.

11. Meetings of the Trustees:

- a) The President of the Board of Trustees shall preside over all the meetings of the trustees and in his absence the Secretary of the Board of Trustees shall preside such meeting and in the absence of both, the trustees attended such meeting may elect any one of them to preside over the meeting;
- b) The meetings of the Trustees may be convened by the President of the Board of Trustees or by any other Trustees of the board of trustees.
- c) The **quorum of the meeting of the Trustees shall be two third** at the time of member of the board of trustees personal presentation in the meeting.
- d) In the event of equality of votes, the person presiding such meeting shall exercise casting vote (additional vote).
- e) The board of trustees shall meet as often as possible but not less than **Three times in a year** for efficient management of the Trust, to consider the income and expenditure and for disposing of all such other matters as may arise in such meetings.

- f) Trustees who fail to attend three consecutive meetings without prior intimation or information shall cease to be Trustees, unless otherwise majority of the other Trustees accord him exception on genuine and valid grounds.
- g) In case of any difference of opinion between the Trustees in any matter connected with the Trust and its administration the decision of the majority will be final and binding on all the Trustees.

12. RESOLUTIONS:

- a) The Trustees may exercise **all the powers vested in them in clause 10** under these presents by resolution passed at a simple majority of the trustees attended such meetings of the Board of Trustees.
- b) Any resolution in writing signed by all Trustees holding office for the time being shall be valid and binding on the trust.

13. SUITS:

The President of the board of Trustees of the Trust is authorized to sue or to be sued on behalf of the Trust.

14. Execution of Documents:

All Deeds, Documents, Forms and declaration etc. shall be executed and signed by the President of the Board of Trustees representing the Trust.

15. ACCOUNTS AND AUDIT:

- a) The Trustees shall maintain true and correct accounts of all Trust monies and of all the income and investments and all the outgoing expenses.
- b) The year of account shall be the financial year commencing from 1st APRIL and ending 31st March.
- c) The Trustees shall each year issue a report setting out the accounts showing the income and expenditure of the Trust for the preceding year not later than six months from the end of the preceding year of accounts.

- d) The accounts of the Trust shall be audited every year by a Chartered Accountant who may be appointed for the purpose by the board of Trustees and the audited statement of accounts together with Auditors' report shall be laid before the Board of Trustees for approval in the Annual General Body meeting of the trust.

16. BANK ACCOUNT:

- a) The President and Treasurer of the Board of the Trustees shall be **jointly open an bank(s) account** in the name of Trust and operate bank account(s) Jointly on behalf of the trust.
- b) The bank(s) account shall be opened in the name of institution and establishment as maintained and administered by the trust and same shall be operated by the President of the board of the Trustees and Head of the Person of the institution and establishment in **Jointly**.

17. POWER TO ALTER RULES AND REGULATIONS:

The Board of Trustees shall have full power and authority to make, alter and rescind rules and regulations for the management and administration of the Trust. Any amendment to the Trust Deed will be carried out only with the approval of the Commissioner of Income Tax in its jurisdiction.

18. APPLICATION OF INCOME AND TRUST FUND:

The Board of Trustees shall be empowered to invest the funds of the Trust in movable or immovable properties, in such manner as they deem fit for the purpose of the objects of the trust provided that such investments shall be in accordance with the provision of Section 13(I) read with Section 11(5) of the Income Tax Act, 1961 as well as of any other law for the time being in force as are applicable to charitable trusts.

19. REMUNERTION TO THE TRUSTEES:

The Trustees are not entitled for any remuneration. But they shall however be entitled to receive out of pocket expenses incurred by them in the course of

discharging the functions of the Trust. Further the Income and funds of the Trust will be solely utilized towards the objects and no portion of it will be utilized for payment of Trustees by way profits, interest, dividend or otherwise.

20. INDEMNITY:

Every Trustee shall be indemnified out of the fund in respect of any loss arising from or contingent upon any investment made out of the monies of the Trust unless such loss shall have been occasioned by own negligence and also every Trustee shall be indemnified out of the Trust against all proceedings, suits, claims, costs, damages and expenses occasioned by any claim in connection with the matters or affairs relating to the Trust created by these presents or in the exercise of powers or discretion vested in them by virtue of these presents.

21. IRREVOCABILITY:

The Trust is irrevocable.



22. DECLARATION :

(a). No part of the income shall ensure or be applied for the benefit of any of the prohibited persons mentioned in Section 13(8) of the Income-tax Act 1961.

23. ACTIVITIES OF THE TRUST:

The activities of the Trust shall be carried out only within India and its Union territories and shall not be extended anywhere outside India.

24. DISSOLUTION:

On dissolution of the Trust, the net assets of the Trust shall be transferred to an association of persons or trust or society having similar objects of this Trust.

25. PROCEEDING OF THE TRUST:

Any defect in the constitution of the Trust shall not invalidate its proceedings.

26. RESIDUARY:

For matters not provided for in these presents, the provisions of the Indian Trust Act, 1882 and the Income Tax Act, 1961 and rules made there under will apply accordingly.
